
Pursuant to the Credit Agreement dated as of December 22, 2020 (as amended, modified, extended, restated, replaced, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among Nice-Pak Products, Inc., a New York corporation as U.S. Borrower, Nice-Pak International Limited, a limited liability company incorporated under the laws of England and Wales as U.K. Borrower (the “Obligor”), the other Guarantors party thereto from time to time and Citizens Bank, N.A., as Administrative Agent (the “Administrative Agent”) for the secured parties referenced therein (the “Secured Parties”), the Obligor, to secure the prompt payment and performance in full when due, whether by lapse of time, acceleration, mandatory prepayment or otherwise, of the Credit Party Obligations (as defined in the Credit Agreement), hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule 1 attached hereto (the “Trademarks”) to the Administrative Agent for the ratable benefit of the Secured Parties and (a) the undersigned hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Obligor in and to the Trademarks.

The Obligors and the Administrative Agent, on behalf of the Secured Parties, hereby acknowledge and agree that the security interest in the Trademarks (i) may only be terminated in accordance with the terms of the Security Agreement and (ii) is not to be construed as an assignment of any Trademark.

THIS NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.


