TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "<u>Agreement</u>") is made and effective as of October 9, 2020 (the "<u>Effective Date</u>") by and between Twin River Management Group, Inc., a Delaware corporation ("<u>Buyer</u>"), on the one hand, and Caesars Entertainment, Inc., a Delaware corporation ("<u>CZR</u>"), and each CZR Subsidiary (as defined in the Purchase Agreement) identified on the signature page(s) of this Agreement (each a "<u>Seller</u>"), on the other hand, (each a "<u>party</u>," and collectively, the "<u>parties</u>").

RECITALS

WHEREAS, Buyer and CZR are parties to that certain Purchase Agreement, dated as of the Effective Date (the "<u>Purchase Agreement</u>"), pursuant to which CZR agrees to sell, transfer, assign and convey ("<u>Transfer</u>"), and to cause each other Seller to Transfer to Buyer, and Buyer agrees to purchase from Sellers, among other things, all of each Sellers' right, title and interest in, to and under certain Assets (as defined in the Purchase Agreement) on the terms and subject to the conditions set forth in the Purchase Agreement;

WHEREAS, the Assets include the Acquired Trademarks (defined below); and

WHEREAS, this Agreement is being entered into to evidence and effectuate the Transfer and delivery of the Acquired Trademarks by each Seller to Buyer in accordance with the terms of the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein, and for other good and valuable consideration, including the consideration set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

ARTICLE I DEFINITIONS

- 1.1 "<u>Acquired Trademarks</u>" means all Bally Trademarks that are owned or purported to be owned in whole or in part by any Seller, including the Trademarks set forth on <u>Exhibit A</u>.
- 1.2 "Bally Trademarks" means all Trademarks that include any of the words, phrases, symbols, designs, devices, logos, emblems, marks, names, signs or insignia set forth on Exhibit B hereto, alone or in combination with other words, phrases, symbols, designs, logos, emblems, signs or insignia, and all variations, derivatives, stylizations and Trademarks formative of any of the foregoing.
- 1.3 "Contract" means any agreement, contract, lease, power of attorney, note, loan, evidence of Indebtedness, purchase order, letter of credit, settlement agreement, franchise agreement, undertaking, covenant not to compete, employment agreement, license, instrument, obligation, commitment, understanding, policy, purchase and sales order, quotation and other

executory commitment to which any Person is a party or to which any of the assets of such Person are subject, whether oral or written, express or implied.

- 1.4 "<u>Governmental Entity</u>" means any court or administrative, regulatory or governmental agency, commission, board, body, authority or instrumentality.
- 1.5 "<u>Law</u>" means any foreign or domestic law, statute, code, ordinance, rule, regulation, order, judgment, writ, stipulation, award, injunction, decree or arbitration award, policies, guidance, court decision, rule of common law or finding.
- 1.6 "Person" means an individual, corporation, limited liability company, partnership, association, trust, unincorporated organization, other entity or "group" (as defined in Rule 13d-5(b)(1) under the Exchange Act).
- 1.7 "<u>Representatives</u>" means, with respect to any Person, its officers, directors, managers, members, employees, investment bankers, consultants, financial or other advisors, agents or other representatives.
- 1.8 "Trademarks" means (i) all trademarks, service marks, trade names, service names, corporate, d/b/a and similar names, taglines, slogans, industrial designs, brand names, brand marks, domain names, social media identifiers, user names, trade dress rights, identifying symbols, designs, logos, emblems, signs or insignia, meta tags, website search terms and key words and other designations of source or origin, including all goodwill associated therewith or symbolized thereby, (ii) all rights in and to any of the foregoing, anywhere in the world, including all common law rights, (iii) all registrations and applications for registration of any of the foregoing, all rights therein, including rights provided by international treaties or conventions, and all reissues, extensions and renewals of any of the foregoing, and (iv) all foreign counterparts, translations and variations of any of the foregoing, in each case, together the right to sue for past, present and future infringement, conflict, dilution or violation of any of the foregoing.

ARTICLE II ASSIGNMENT OF ACQUIRED TRADEMARKS

Assignment. Each Seller hereby irrevocably Transfers and delivers to Buyer, and Buyer hereby accepts, all of such Seller's right, title and interest in and to the Acquired Trademarks, including without limitation (a) all rights in and to any of the foregoing, anywhere in the world, including all registrations, applications for registration and common law rights, (b) all renewals and extensions of the Acquired Trademarks; (c) all goodwill of the business connected with the use of, and symbolized by, each Acquired Trademark; (d) all income, royalties, proceeds at any time due or payable or asserted under and with respect to any of the foregoing and (e) all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof, for the use and enjoyment of Buyer's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by such Seller if this sale, conveyance, transfer and assignment had not been made.

2.2 <u>Recordation</u>. Each Seller authorizes and requests the Commissioner of the U.S. Patent and Trademark Office and any other similar Governmental Entity in countries foreign to the United States to record Buyer as the assignee and owner of all right, title and interest in and to the Acquired Trademarks to Buyer.

2.3 Further Assurances.

- (a) Each Seller will and will cause its Representatives and legal successors and assigns, upon reasonable request and without further compensation but at Buyer's expense, to promptly execute, acknowledge and deliver all such further conveyances, notices, assumptions, assignments, releases, electronic forms and other instruments, and take such further actions, as may be reasonably necessary or appropriate to assure fully to Buyer all of the rights intended to be Transferred to Buyer under this Agreement and the Purchase Agreement with respect to the Acquired Trademarks and to otherwise make effective the transactions contemplated hereby and thereby, including as may be necessary or desirable for obtaining, sustaining, reissuing or enforcing said registrations of the Acquired Trademarks, and for perfecting, recording, or maintaining the title of Buyer, its successors and assigns, to such Acquired Trademarks and any registrations issued for such Acquired Trademarks.
- (b) In the event that any Seller fails to comply with their obligations with respect to any Acquired Trademarks, each Seller designates as its agent and attorney-in-fact Buyer and its Affiliates and its and their duly authorized Representatives, to act for, on behalf of and instead of Sellers to execute and file any document and to do all other lawfully permitted acts necessary to give effect to the transactions contemplated hereby, with the same legal force and effect as executed or done by such Seller.

ARTICLE III MISCELLANEOUS

- 3.1 <u>Expenses</u>. Except as otherwise provided in this Agreement and the Purchase Agreement, all fees and expenses incurred in connection with the transactions contemplated hereby will be paid by the party incurring such fees or expenses.
- 3.2 <u>Binding Effect</u>. This Agreement shall be binding upon and inure to the benefit of each Seller and the Buyer and their respective successors and assignees in accordance with the Purchase Agreement.
- 3.3 <u>Headings</u>. The headings contained in this Agreement are for reference purposes only and will not affect in any way the meaning or interpretation of this Agreement.
- 3.4 <u>Entire Agreement</u>. This Agreement and the Purchase Agreement and all documents and instruments referred to herein and therein constitute the entire agreement and supersede all prior agreements and understandings, both written and oral, among the parties with respect to the subject matter hereof and thereof.
- 3.5 <u>Severability</u>. If any term or other provision of this Agreement is invalid, illegal or incapable of being enforced by any rule of Law or public policy, all other conditions and provisions of this Agreement will nevertheless remain in full force and effect, and the application

of such provision to other Persons or circumstances will not be affected by such invalidity or unenforceability, nor will such invalidity or unenforceability affect the validity or enforceability of such provision, or the application thereof, in any other jurisdiction. Upon such determination that any term or other provision is invalid, illegal or incapable of being enforced, the parties will negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in an acceptable manner to the end that transactions contemplated hereby are fulfilled to the extent possible.

3.6 Governing Law; Consent to Jurisdiction; Waiver of Trial by Jury.

- (a) This Agreement and the transactions contemplated hereby, and all disputes between the parties under or related to the Agreement or the facts and circumstances leading to its execution, whether in Contract, tort or otherwise, will be governed by and construed in accordance with the Laws of the State of Delaware, applicable to Contracts executed in and to be performed entirely within the State of Delaware, without regard to the conflicts of laws principles thereof to the extent that the Laws of another jurisdiction would apply as a result of the application thereof.
- Each of the parties irrevocably and unconditionally submits, for itself, to the exclusive jurisdiction of the Court of Chancery of the State of Delaware, or Federal court of the United States of America, sitting in Delaware, and any appellate court from any thereof, in any action or proceeding arising out of or relating to this Agreement or for recognition or enforcement of any judgment relating thereto, and each of the parties hereby irrevocably and unconditionally (i) agrees not to commence any such action or proceeding except in such courts, (ii) agrees that any claim in respect of any such action or proceeding may be heard and determined in the Court of Chancery or, to the extent permitted by Law, in such Federal court, (iii) waives, to the fullest extent it may legally and effectively do so, any objection that it may now or hereafter have to the laying of venue of any such action or proceeding in the Court of Chancery or such Federal court, (iv) waives, to the fullest extent permitted by Law, the defense of an inconvenient forum to the maintenance of such action or proceeding in the Court of Chancery or such Federal court, and (v) to the extent such party is not otherwise subject to service of process in the State of Delaware, appoints Corporation Service Company as such party's agent in the State of Delaware for acceptance of legal process and agrees that service made on any such agent will have the same legal force and effect as if served upon such party personally within such state. Each of the parties hereby agrees that a final judgment in any such action or proceeding will be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by Law. Each party irrevocably consents to service of process in the manner provided for notices in Section 6.4 of the Purchase Agreement. Nothing in this Agreement will affect the right of any party to serve process in any other manner permitted by Law. Notwithstanding the foregoing, each Seller hereby (x) agrees that service of process, summons, notice or document by registered mail addressed to it at its address provided in Section 6.4 of the Purchase Agreement will be effective service of process against it for any such action brought in any such court, (y) waives and hereby irrevocably waives, to the fullest extent permitted by law, any objection which it may now or hereafter have to the laying of venue of, and the defense of an inconvenient forum to the maintenance of, any such action in any such court, and (z) agrees that a final judgment in any such action will be conclusive and maybe enforced in other jurisdictions by suit on the judgment or in any other manner provided by Law.

- (c) EACH PARTY ACKNOWLEDGES AND AGREES THAT ANY CONTROVERSY THAT MAY ARISE UNDER THIS AGREEMENT IS LIKELY TO INVOLVE COMPLICATED AND DIFFICULT ISSUES, AND THEREFORE IT HEREBY IRREVOCABLY AND UNCONDITIONALLY WAIVES ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LITIGATION DIRECTLY OR INDIRECTLY ARISING OUT OF OR RELATING TO THIS AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY. EACH PARTY CERTIFIES AND ACKNOWLEDGES THAT (I) NO REPRESENTATIVE, AGENT OR ATTORNEY OF ANY OTHER PARTY HAS REPRESENTED, EXPRESSLY OR OTHERWISE, THAT SUCH OTHER PARTY WOULD NOT, IN THE EVENT OF LITIGATION, SEEK TO ENFORCE EITHER OF SUCH WAIVERS, (II) IT UNDERSTANDS AND HAS CONSIDERED THE IMPLICATIONS OF SUCH WAIVERS, (III) IT MAKES SUCH WAIVERS VOLUNTARILY, AND (IV) IT HAS BEEN INDUCED TO ENTER INTO THIS AGREEMENT BY, AMONG OTHER THINGS, THE MUTUAL WAIVERS AND CERTIFICATIONS IN THIS SECTION 3.6(c).
- 3.7 <u>Counterparts</u>. This Agreement may be executed in any number of counterparts and by the different parties in separate counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or PDF file (portable document format file) will be effective as delivery of a manually executed counterpart of this Agreement.


