RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Release") is made as of December 18, 2020 ("Effective Date") executed by Madison Capital Funding LLC ("Agent") in favor of RxBenefits, Inc. ("Grantor").

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 2, 2018 at Reel 6401 Frame 0753; and

WHEREAS, the Agent wishes to release and restore all of its right, title and interest in and to the Trademark Collateral to the Grantor as set forth on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels and releases any and all security interests or liens it has against the Trademark Collateral, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and grants, assigns and conveys without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademark Collateral.
