TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of December 21, 2020, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Agent"), to **HEALTHX, INC.**, an Indiana corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 16, 2016, made by Grantor in favor of Agent (the "Security Agreement"), a security interest was granted by the Grantor to Agent in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on January 3, 2017 at Reel/Frame 5957/0535;

WHEREAS, Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in (i) the intellectual property listed on Exhibit A hereto and (ii) the Trademark Collateral (as defined in the Security Agreement).

2. Release of Security Interest. Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in the Intellectual Property (if any).
