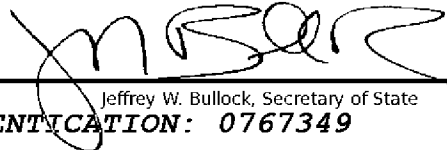

**FIRST:** That at a meeting of the Board of Directors of
