**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of December 23, 2020 (the “Effective Date”) by Virtus Group, LP (the “Administrative Agent”), in favor of CSafe, LLC (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement (as defined below), as applicable.

**WHEREAS**, Grantor and the Administrative Agent entered into that certain Trademark Security Agreement dated October 31, 2016 (the “Trademark Security Agreement”), under which Grantor granted and charged in favor of the Administrative Agent (for the benefit of the other Secured Parties), by way of collateral security, all of the Trademark Collateral; and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 1, 2016, at Reel 5912, Frame 0442;

**WHEREAS**, Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement, (ii) releases any and all liens, security interests, right, title and interest the Administrative Agent or any Secured Party may have in, to or under the Trademark Collateral, and (iii) re-assigns to Grantor, any right, title or interest the Administrative Agent or any Secured Party may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
