Assignors authorize and request any official whose duty it is to issue trademarks, to issue any renewals or extensions to Assignee or its successors or assigns. Assignors authorize the United States Patent and Trademark Office to record the transfer of the registration for the Trademarks to Assignee as recipient of Assignors’ entire right, title, and interest therein.

2. Ownership. Assignors acknowledge Assignee's exclusive right, title and interest in and to the attached listed Trademarks in Schedule A and all registrations or applications for registration thereof, and will not at any time do or cause to be done any act contesting or in way impairing or tending to impair such rights, title and interest in full exercise thereof.

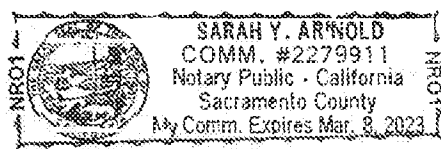
