**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 22, 2020 (this “Release”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as collateral agent (in such capacity, the “Agent”), in favor of VERTELLUS HOLDINGS LLC, VERTELLUS LLC, VERTELLUS FOREIGN HOLDINGS LLC, VERTELLUS INTEGRATED PYRIDINES LLC, VERTELLUS BELGIUM HOLDCO LLC, VERTELLUS BAYONNE LLC, VERTELLUS DWG LLC, VERTELLUS GREENSBORO LLC and VERTELLUS ZEELAND LLC (“Grantors”). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Grantors and the Agent entered into that certain Trademark Security Agreement, dated as of October 31, 2016 (the “Security Agreement”), pursuant to which the Grantors granted to the Agent a security interest in and to all of their right, title and interest in, to and under the Trademark Collateral owned by the Grantors including, without limitation, the trademark registrations and applications listed on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on November 1, 2016 at Reel 005911 and Frame 0691; and

WHEREAS, the Grantors have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Security Agreement in the Trademark Collateral, (b) discharge and release its security interest in and to the Trademark Collateral, and (c) reassign any and all rights, title and interest it has in the Trademark Collateral to the Grantors.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.


