INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** ("IP Assignment Agreement") is made as of November 30, 2020, between Dasko Identification Products, Inc., a Rhode Island corporation (the "Seller"), and Peak Technologies, Inc., an Illinois corporation (the "Purchaser"), pursuant to, and subject to the terms of, that certain Asset Purchase Agreement by and among Purchaser, Seller and Paul Movsesian, of even date herewith (the "Purchase Agreement"). Capitalized terms used but not defined herein shall have the meanings set forth in the Purchase Agreement.

WHEREAS, pursuant to the Purchase Agreement, Seller has agreed to convey to Purchaser all of the Seller's rights, title, and interests in and to all of the Seller's Intellectual Property, including without limitation, the Intellectual Property listed on Exhibit A attached hereto.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The Seller does hereby absolutely, irrevocably and unconditionally sell, assign, convey, transfer and deliver to Purchaser, its successors and assigns, all of Seller's right, title and interest in and to the Intellectual Property, free and clear of any Liens.
2. The Purchaser does hereby accept the assignment set forth above.
3. This IP Assignment Agreement may not be amended or terminated except by a written instrument duly signed by each of the parties hereto. This IP Assignment Agreement shall inure to the benefit of, and be binding upon, each of the parties hereto and their respective successors and assigns.
4. Nothing in this IP Assignment Agreement, expressed or implied, is intended or shall be construed to confer upon or give to any person, firm or corporation other than the Purchaser and the Seller, their successors and assigns, any remedy or claim under or by reason of this instrument or any term, covenant or condition hereof, and all of the terms, covenants, conditions, promises and agreements contained in this instrument shall be for the sole and exclusive benefit of the Purchaser and the Seller, and their respective successors and assigns.
5. This IP Assignment Agreement and the legal relations among the parties hereto will be governed by and construed in accordance with the internal substantive laws of the State of Delaware (without regard to the laws of conflict that might otherwise apply) as to all matters, including without limitation, matters of validity, construction, effect, performance and remedies.
6. Each of the parties hereto irrevocably submits to the exclusive jurisdiction of the federal courts of the United States located in Delaware, for the purposes of any such action or other proceeding arising out of this IP Assignment Agreement or any transaction contemplated hereby. Each party waives a right to a jury trial.

7. Nothing in this IP Assignment Agreement supersedes, expands, or extinguishes any of the obligations, agreements, covenants, representations or warranties of the Seller or the other parties contained in the Purchase Agreement. This IP Assignment Agreement shall be subject to the terms, conditions and covenants set forth in the Purchase Agreement and any conflict or inconsistency exists between this IP Assignment Agreement and the Purchase Agreement, then the terms of the Purchase Agreement shall control.

8. This IP Assignment Agreement may be executed simultaneously with original, facsimile, or .pdf signatures in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.
