TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL  
PROPERTY RIGHTS (TERM LOAN)

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (TERM LOAN) (this "Release"), dated as of December 24, 2020, from BANK OF AMERICA, N.A., in its capacity as administrative agent and collateral agent (the "Agent") for the Lenders that are parties to the Credit Agreement, dated as of April 12, 2012 (as amended, amended and restated, waived, supplemented or otherwise modified from time to time, together with any agreement extending the maturity of, or restructuring, refunding, refinancing or increasing the Indebtedness under such agreement or successor agreements, the "Credit Agreement"), among HD Supply, Inc., a Delaware corporation (the "Borrower"), the Agent, as administrative agent and collateral agent and the other parties thereto, to HD Supply, Inc., a Delaware corporation, HD Supply Holdings, LLC, a Florida limited liability company, HDS IP Holding, LLC, a Nevada limited liability company, HD Supply Support Services, Inc., a Delaware corporation, HD Supply Facilities Maintenance, Ltd, a Florida corporation, HD Supply FM Services, LLC, a Delaware limited liability company, HD Supply GP & Management, Inc., a Delaware corporation, HD Supply Management, Inc., a Florida corporation (together with the Borrower, each, individually, a "Grantor" and, collectively, the "Grantors"). Capitalized terms used herein without definition are used as defined in the Credit Agreement or the Collateral Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS pursuant to that certain Guarantee and Collateral Agreement, dated as of April 12, 2012, as amended, amended and restated, waived, supplemented or otherwise modified from time to time (the "Collateral Agreement"), made by the Borrower and certain of its subsidiaries in favor of the Agent, each Grantor granted to the Agent, for the rate benefit of the Secured Parties, a security interest (the "Security Interest") in certain Collateral, including Intellectual Property, as collateral security for the prompt and complete payment and performance when due of the Obligations of such Grantor;

WHEREAS, in connection with the Guarantee and Collateral Agreement, each Grantor and the Agent entered into (i) an Notice and Confirmation of Grant of Security Interest in Trademarks, which was recorded with the United States Patent and Trademark Office on April 12, 2012 at Reel 4755, Frame 0623, (ii) a Notice and Confirmation of Grant of Security Interest in Trademarks, which was recorded with the United States Patent and Trademark Office on July 27, 2012 at Reel 4831, Frame 0001, (iii) a Notice and Confirmation of Grant of Security Interest in Trademarks, which was recorded with the United States Patent and Trademark Office on December 5, 2014 at Reel 5414, Frame 0491, (iv) a Notice and Confirmation of Grant of Security Interest in Trademarks, which was recorded with the United States Patent and Trademark Office on March 6, 2018 at Reel 6284, Frame 0778, (v) a Notice and Confirmation of Grant of Security Interest in Trademarks, which was recorded with the United States Patent and Trademark Office on March 6, 2018 at Reel 6295, Frame 0685, (vi) a Notice and Confirmation of Grant of Security Interest in Trademarks, which was recorded with the United States Patent and Trademark Office on March

28, 2018 at Reel 6301, Frame 0468, and (vii) a Grant of Security Interests in Copyrights, which was recorded with the United States Copyright Office on April 23, 2012 at Volume 3604, Document 705 (collectively, "IP Security Agreements");

WHEREAS, the Agent has agreed to terminate and release the Security Interest in the Intellectual Property under the Collateral Agreement and the IP Security Agreements, including those listed on Schedule A attached hereto (the "Released IP") of each Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Release of Security Interest. The Agent hereby terminates, cancels, releases and discharges all of its Security Interest, and all other right, title and interest (whether created under the Credit Agreement, Collateral Agreement, IP Security Agreements or otherwise), in and to the Released IP and any other Intellectual Property of each of the Grantors, and hereby terminates the IP Security Agreements. Any right, title or interest of the Agent in the Released IP and any other Intellectual Property of each of the Grantors shall hereby cease and become void.

2. Further Assurances. The Agent shall promptly and duly execute and deliver to each Grantor all further releases and other documents (including, without limitation, Uniform Commercial Code termination statements), and take all other actions as each Grantor may reasonably request, at each Grantor's sole cost and expense, for the purpose of obtaining the release of the Security Interest.

3. Recordation. The Agent hereby authorizes and requests the Commissioner of Patents and the Commissioner of Trademarks of the United States of America and the Register of Copyrights of the United States to note and record the existence of this Release.

4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.






