**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of December 28, 2020, and made by CORBEL CAPITAL PARTNERS SBIC, L.P., as administrative agent (in such capacity, together with its successors and assigns in such capacity, "Agent"), having an office at 11777 San Vicente Blvd., Suite 777, Los Angeles, CA 90049, to INCEPTION HOLDING, LLC, a New Jersey limited liability company, and THE INCEPTION COMPANY, LLC, a New Jersey limited liability company (collectively, the "Grantors"), with their chief executive offices at 14 Madison Road, Unit G, Fairfield, NJ 07004.

WHEREAS, Grantors and Agent entered into that certain Trademark Security Agreement, dated July 24, 2020 (the "Trademark Security Agreement"), in which a security interest was granted by Grantors in favor of Agent in certain Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 31, 2020, at Reel 7012 Frame 0541; and

WHEREAS, Agent now desires to terminate and release the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall have the meaning set forth in the Trademark Security Agreement and shall mean and include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A attached hereto.

2. Release of Security Interest. Agent hereby terminates the Trademark Security Agreement, and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to Grantors all right, title and interest it may have in and to the Trademark Collateral without recourse and without any representation or warranty.
