RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is dated as of December 28, 2020 by HARVEST CAPITAL CREDIT CORPORATION, AS PURCHASER, (in such capacity, the “Purchaser”), in favor of Yucatan Foods, LLC (f/k/a Yucatan Foods, L.P. (“Borrower”) All capitalized terms used but not otherwise defined herein have the meanings given to them in the Note Purchase Agreement (as defined below).

WHEREAS, the Borrower and Purchaser, and other parties thereto, entered into that certain Senior Subordinated Note Purchase, Guaranty and Security Agreement dated as of March 19, 2017 (as amended by that certain Waiver and First Amendment dated as of June 20, 2016 and as further amended, restated, supplemented or otherwise modified from time to time, the “Note Purchase Agreement”).

WHEREAS, pursuant to the Note Purchase Agreement and related documents, the Borrower granted to the Purchaser a security interest in all of Borrower’s right, title and interest in, to and under all Trademarks of such Borrower set forth in Schedule A hereto (“Trademark Collateral”);

WHEREAS, the Borrower executed and delivered to the Purchaser that certain Intellectual Property Security Agreement, dated as of March 29, 2016 (the “Trademark Security Agreement”), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Trademark and Trademark Office on April 11, 2016 at Reel/Frame 5764/0198; and

WHEREAS, the Purchaser desires to terminate and release the entirety of its security interest in the Trademark Collateral referred to in Schedule A.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Purchaser, hereby terminates, releases and forever discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to the Borrower any right, title or interest the Purchaser may have in, to or under the Trademark Collateral. For clarity, the Purchaser is only terminating, releasing and discharging its security interest in the trademark set forth in Schedule A hereto.


