**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 16, 2020 (“Release”), is made by **FIDUS MEZZANINE CAPITAL II, L.P.**, a Delaware limited partnership, as agent (“Agent”) in favor of **PFANSTIEHL, INC.**, a Delaware corporation (“Grantor”), pursuant to that certain Amended and Restated Senior Subordinated Loan and Security Agreement dated April 30, 2020 (as amended, modified, restated or supplemented from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, Grantor executed and delivered a certain Grant of Security Interest in Trademarks, which is recorded at the United States Patent and Trademark Office (“USPTO”) on May 13, 2020 at Reel 6938/Frame 0012 (“Notice”), whereby Grantor granted to Agent, a continuing security interest in any and all of Grantor’s right, title, and interest in and to Trademarks, including those Trademarks listed on Schedule A attached hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby irrevocably terminates, cancels, discharges, and releases the continuing security interest in Grantor’s right, title, and interest in and to the Trademarks granted pursuant to the Credit Agreement and the Notice. The Agent hereby authorizes the Grantor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Trademarks contemplated hereby. Agent agrees to execute and deliver to the Grantor all other instruments and other documents as the Grantor may reasonably request to release the security interest in the Trademarks which had been granted under the Notice, in each case, at the sole expense of the Grantor (which shall reimburse the Agent for its reasonable expenses, including reasonable expenses of counsel, in connection therewith).
