**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of December 29, 2020, is made by Antares Capital LP, in its capacity as administrative agent and collateral agent (in such capacity, the "Agent") for the Secured Parties (as defined in the Credit Agreement defined in the First Lien Security Agreement defined below), in favor of ICP Adhesives and Sealants, Inc., an Ohio corporation, ICP Construction, Inc., a Massachusetts corporation (for itself and as successor by merger to Arizona Polymer Flooring, LLC, a Delaware limited liability company), ICP Industrial, Inc., an Illinois corporation, Nicoat Environmental Specialties, LLC, an Illinois limited liability company, and Pli-Dek, LLC a Delaware limited liability company (collectively, the "Grantors"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of November 3, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "First Lien Security Agreement"), by the Grantors and the other parties party thereto in favor of the Agent, and those certain agreements described on Annex I attached hereto (the "Trademark Security Agreements" and, collectively with the First Lien Security Agreement, the "Security Agreements"), the Grantors granted a security interest (the "Security Interest") in all right, title and interest in or to the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Agent now desires to terminate and release the Trademark Security Agreements and the entirety of its Security Interest in the Trademark Collateral (as hereinafter defined).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall have the meaning ascribed to such term in each respective Trademark Security Agreement, and shall include (i) all trademarks, trademark registrations and trademark applications of the Grantors, including, without limitation, those listed on Annex II hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and (ii) all proceeds of the foregoing, including, without limitation, any claim by Grantors against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application, including, without limitation, those listed on Annex II hereto, or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages. Capitalized terms not defined herein have the meanings set forth in the Security Agreements, as applicable.

2. Release of Security Interest. The Agent, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors

and assigns, its Security Interest in and to the Trademark Collateral, and the Trademark Security Agreements and any and all right, title and interest that the Agent may have in, to and under the Trademark Collateral is hereby reassigned to the Grantors, as applicable. The Agent hereby (i) authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Agent's Security Interest in the Trademark Collateral; and (ii) agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' expense, to more fully and effectively effectuate the purpose of this Release.

3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release. The parties hereby agree that the electronic signatures of the parties will have the same force and effect as a manual signatures.

4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.




