RELEASE OF TRADEMARK COLLATERAL AGREEMENT

THIS RELEASE OF TRADEMARK COLLATERAL AGREEMENT is dated December 28, 2020, by BMO Harris Bank N.A., a national banking association, acting as administrative agent for the Secured Creditors (in such capacity, the “*Administrative Agent*”). Capitalized terms used herein but not defined shall have the same meanings herein as defined in the Trademark Collateral Agreement (as defined below).

WITNESSETH:

WHEREAS, the Administrative Agent, CRST International, Inc., an Iowa corporation (“*International*”), North American Logistics Group LLC, a Delaware limited liability company (“*NALG*”) and Installs LLC, a Delaware limited liability company (“*Installs*” and collectively with NALG and International, the “*Debtors*” and each, a “*Debtor*”) are parties to a certain Trademark Collateral Agreement, dated as of February 28, 2020 (the “*Trademark Collateral Agreement*”), which was recorded in the United States Patent and Trademark Office on April 6, 2020 at (i) in the case of NALG, Reel 6908 and Frame 0821, (ii) in the case of International, Reel 6908 and Frame 0801 and (iii) in the case of Installs, Reel 6908 and Frame 0814, in each case pursuant to which the Debtors granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademarks*”); and

WHEREAS, the Debtors have requested that the Administrative Agent release its security interests in the Trademarks and reassign the same to the respective Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Administrative Agent hereby releases its security interests in, and reassigns, grants and conveys to the applicable Debtor, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to the following:


(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) All proceeds of the foregoing.
