**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 29, 2020, by **CCP Agency, LLC**, as Agent for itself, the other Lenders and the other Secured Persons (“Agent”), in favor of Altruista Health, Inc., a Delaware corporation (“Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them, directly or by reference, in the Agreement.

WITNESSETH:

WHEREAS, Agent and Grantor are parties to that certain Trademark Security Agreement, dated as of June 19, 2020 (the “**Agreement**”), pursuant to which Grantor granted, pledged and collaterally assigned a security interest to Agent in the Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent; and

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 19, 2020, at Reel 6975, Frame 0737; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates the Agreement and hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):

a. all of its Trademarks, including, without limitation, those referred to on Schedule 1 hereto;

b. all renewals and extensions of the foregoing;

c. all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

d. all Proceeds and products hereof, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, or (ii) injury to goodwill associated with such Trademarks.


