RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This **TRADEMARK RELEASE** ("Release") is made as of December 22, 2020 ("Effective Date") executed by CIT BANK, N.A., as Administrative Agent (the "Agent") in favor of REMITA HEALTH MANAGEMENT LLC, a California limited liability company ("Remita") and GERINET PALLIATIVE CARE, LLC, an Arizona limited liability company ("GeriNet" and Remita, each individually a "Grantor" and collectively the "Grantors"). Capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Short Form Intellectual Property Security Interest in Trademarks Agreement (as amended, restated or supplemented from time to time, "Trademark Security Agreement") referenced below or the Security and Pledge Agreement (as defined in the Trademark Security Agreement), as applicable.

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of September 30, 2020, made by the Grantors in favor of the Agent, the Grantors granted to the Agent a security interest in and to all of the Grantors' right, title and interest, in, to and under (i) each of the trademarks listed on the attached Schedule 1 (the "Trademarks") and (ii) all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application referred to in Schedule 1 (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 2, 2020 at Reel 7067 Frame 0886 and on October 5, 2020 at Reel 7087 Frame 0128; and


WHEREAS, the Agent wishes to terminate the Trademark Security Agreement and release and restore all right, title and interest in, to and under the Trademark Collateral to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreement in respect of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or Liens it has and all of its right, title and interest in, to and under the Trademark Collateral, whether now owned or hereafter created or acquired by the Grantors, and (iii) reassigns, grants and conveys to the Grantors, without any representation, recourse or undertaking by the Agent, any and all of the Agent's right, title and interest in, to and under the Trademark Collateral.
