**DEED OF ASSIGNMENT OF BUSINESS INTELLECTUAL PROPERTY RIGHTS**

BETWEEN

**WILD AND WOLF (HOLDINGS) LIMITED**

AND

**WILD AND WOLF LIMITED**

AND

**WILD AND WOLF INC**

AND

**CHRONICLE BOOKS LLC**

**THIS DEED OF ASSIGNMENT** is made on 11 November 2020

## **PARTIES**

- (1) **WILD AND WOLF (HOLDINGS) LIMITED** incorporated and registered in England and Wales with company number 08318227 whose registered office is at 20 Manvers Street, Bath, England BA1 1JW (the "**W&W Holdings**");
- (2) **WILD AND WOLF LIMITED** incorporated and registered in England and Wales with company number 05382617 whose registered office is at 20 Manvers Street, Bath, England BA1 1JW ("**W&W UK**");
- (3) **WILD AND WOLF INC** incorporated and registered under the laws of Delaware, USA with company number 05452707 whose registered office is at 1209 Orange Street, Wilmington, Delaware 19801 ("**W&W Inc**"); and
- (4) **CHRONICLE BOOKS LLC** a limited liability company formed under the laws of Delaware, USA with file number 3122926 whose registered office is at 1209 Orange Street, Wilmington, Delaware 1980 (the "**Buyer**").

## **BACKGROUND**

- (A) W&W Holdings, W&W UK and W&W Inc (each a "**Seller**" and together the "**Sellers**") own the Business Intellectual Property Rights.
- (B) The Buyer and the Sellers have entered into an asset sale and purchase agreement dated on or around the date of this agreement (the "**Main Agreement**").
- (C) Pursuant to the Main Agreement, the Sellers have agreed to assign the Business Intellectual Property Rights to the Buyer on the terms set out in this agreement.

## **AGREED TERMS**

### **1 INTERPRETATION**

- 1.1 Terms used but not defined in this agreement shall have the meaning attributed to them in the Main Agreement unless indicated otherwise in this agreement.
- 1.2 A person includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.3 The Schedule forms part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedule.
- 1.4 References to clauses and the Schedule are to the clauses of and the Schedule to this agreement.

- 1.5 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.6 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.7 This agreement shall be binding on, and enure to the benefit of, the parties to this agreement and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.
- 1.8 A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time.
- 1.9 A reference to a statute or statutory provision shall include all subordinate legislation made from time to time.
- 1.10 A reference to writing or written includes fax but not email.
- 1.11 Any words following the terms including, include, in particular, for example or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

## 2 ASSIGNMENT

- 2.1 Pursuant to and for the consideration set out in the Main Agreement (the sufficiency and receipt of which is hereby acknowledged by the parties), the Sellers hereby assign to the Buyer absolutely all its right, title and interest in and to the Business Intellectual Property Rights (including the registered trade marks (the "**Trade Marks**"), the unregistered trade mark (the "**Unregistered Mark**"), the domain names (the "**TPG Domain Names**"), the social media platforms ("**Social Media Platforms**"), the TPG Moulds and Tooling, as set out in the Schedule to this agreement, and the Goodwill), including:
  - 2.1.1 all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods and/or services in respect of which the Trade Marks are registered or used;
  - 2.1.2 all statutory and common law rights attaching to the Unregistered Mark, together with the goodwill of the business relating to the goods and/or services in respect of which the Unregistered Mark is used;
  - 2.1.3 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Business Intellectual Property Rights whether occurring before, on, or after the date of this agreement; and

- 2.1.4 ownership and control of the TPG Domain Names and Social Media Platforms.
- 2.2 Insofar as any Business Intellectual Property Rights do not vest in the Buyer automatically by operation of law and/or the assignment under this agreement is ineffective:
  - 2.2.1 the Sellers hold legal title in such Business Intellectual Property Rights which do not so vest and/or are not so assigned (“**Retained Rights**”) on trust for the Buyer; and
  - 2.2.2 the Sellers hereby grant to the Buyer a licence to practice and exploit the Retained Rights on the same terms which would apply to the assignment envisaged under this agreement.

### **3 DOMAIN NAME AND SOCIAL MEDIA PLATFORM TRANSFER PROCEDURE**

- 3.1 The Sellers shall promptly, following Completion under the Main Agreement (and, in any event, in accordance with any time limits imposed by relevant domain name registries and registrars), complete all such formalities, including:
  - 3.1.1 the provision of TPG Domain Names and Social Media Platforms account details and passwords to the Buyer;
  - 3.1.2 the selection and completion of relevant change of registrant and administrative contact functions relevant to such TPG Domain Names and Social Media Platforms accounts;
  - 3.1.3 the provision of email or other online notice or confirmation notifying the registrar of the transfers to the Buyer;
  - 3.1.4 the changing of webhosts; and
  - 3.1.5 the execution of all documents, papers, forms and authorisations,as are necessary to perfect the transfer of the TPG Domain Names and Social Media Platforms by registering them in the Buyer's name.

### **4 FURTHER ASSURANCE**

- 4.1 The Buyer's sole cost and expense, the Sellers shall, and shall use reasonable endeavours to procure that any necessary third party shall, promptly execute and deliver such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement and vesting the full benefit of the right, title and interest in and to the Business Intellectual Property Rights in the Buyer, including:
  - 4.1.1 registration of the Buyer as proprietor of the Business Intellectual Property Rights; and
  - 4.1.2 assisting the Buyer in obtaining, defending and enforcing the Business Intellectual Property Rights and the Goodwill, and assisting with any other proceedings which may be brought

by or against the Buyer against or by any third party relating to the Business Intellectual Property Rights and the Goodwill.

- 4.2 Each of the Sellers appoint the Buyer to be its attorney in their name and on its behalf to execute documents, use the Sellers' names and do all things which are necessary or desirable for the Buyer to obtain for itself or its nominee the full benefit of this agreement.
- 4.3 These powers of attorney are irrevocable and are given by way of security to secure the performance of the Sellers' obligations under this agreement and the proprietary interest of the Buyer in the Business Intellectual Property Rights and so long as such obligations of the Sellers remain undischarged, or the Buyer has such interest, the powers may not be revoked by the Sellers, save with the consent of the Buyer.
- 4.4 Without prejudice to the generality of clause 4.2, the Buyer may, in any way it thinks fit and in the name and on behalf of the Sellers:
- 4.4.1 take any action that this agreement requires the Sellers to take;
  - 4.4.2 exercise any rights which this agreement gives to the Sellers; and
  - 4.4.3 appoint one or more persons to act as substitute attorney(s) for the Sellers and to exercise such of the powers conferred by these powers of attorney as the Buyer thinks fit and revoke such appointment.
- 4.5 The Sellers undertake to ratify and confirm everything that the Buyer and any substitute attorney does or arranges or purports to do or arrange in good faith in exercise of any power granted under this clause.

## **5 LIABILITY AND RELATED AGREEMENTS**

- 5.1 The parties agree and acknowledge that:
- 5.1.1 this agreement is ancillary to the Main Agreement, and forms part of the wider Transaction; and
  - 5.1.2 should a dispute arise in relation to the Transaction, each party should not sue, commence, voluntarily aid in any way, prosecute or cause to be commenced or prosecuted against the other party any action, suit or other proceeding under this agreement in this jurisdiction or any other until it has first exhausted its legal rights and dispute resolution process under the Main Agreement.
- 5.2 Subject to clause 5.1.2, in proceedings for breach of this agreement either party may:
- 5.2.1 rely on any limit of liability or other term of the Main Agreement; and

5.2.2 raise equivalent rights of defence as it would have under the Main Agreement, had that party been a party to the Main Agreement.

## **6 VARIATION AND WAIVER**

6.1 No variation of this agreement shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

6.2 A waiver of any right or remedy under this agreement or by law is only effective if it is given in writing and shall not be deemed a waiver of any subsequent right or remedy.

6.3 A failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall not constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict any further exercise of that or any other right or remedy.

6.4 No single or partial exercise of any right or remedy provided under this agreement or by law shall prevent or restrict the further exercise of that or any other right or remedy.

## **7 ENTIRE AGREEMENT**

This agreement (together with the documents referred to in it (including the Main Agreement) constitutes the entire agreement between the parties in relation to the Transaction and supersedes any previous agreement between the parties in respect of the same.

## **8 SEVERANCE**

8.1 If any provision or part-provision of this agreement is or becomes invalid, illegal or unenforceable, it shall be deemed deleted, but that shall not affect the validity and enforceability of the rest of this agreement.

8.2 If any provision or part-provision of this agreement is deemed deleted under clause 8.1 the parties shall negotiate in good faith to agree a replacement provision that, to the greatest extent possible, achieves the intended commercial result of the original provision.

## **9 THIRD PARTY RIGHTS**

This agreement does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this agreement.

## **10 GOVERNING LAW**

This agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.






## **11 JURISDICTION**
