WORLDWIDE TRADEMARK ASSIGNMENT AGREEMENT

THIS ASSIGNMENT effective as December 9, 2019 (the "**Effective Date**"), by and between **GILDAN ACTIVEWEAR INC.**, a Canadian corporation, having its principal place of business at 600, de Maisonneuve Boulevard West, 33rd Floor, Montreal, Province of Quebec, Canada, H3A 3J2, Canada (the "**Assignor**"), and **GILDAN ACTIVEWEAR SRL**, a Barbados society with restricted liability with offices at Newton, Christ Church, Barbados, BB17047 (the "**Assignee**").

WHEREAS the Assignor is the owner of the trademarks listed on Schedule "A" attached hereto, including any applications therefor or registrations thereof (the "**Trademarks**"); and

WHEREAS pursuant to a Worldwide Intellectual Property Assignment Agreement entered into as of the date hereof between the Assignor and the Assignee (the "**IP Agreement**"), the Assignee has acquired all of the Assignor's rights, title and interest in and to the Trademarks and the goodwill associated therewith; and

WHEREAS the Assignor and the Assignee desire to memorialize the transfer of the Trademarks from the Assignor to the Assignee.

NOW, THEREFORE, the Assignor declares as follows:

In consideration of the IP Agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby confirms the sale, assignment and transfer to the Assignee of all of the Assignor's right, title and interest in and to the Trademarks and the goodwill connected with the use and as symbolized by the Trademarks, all common law and statutory rights related thereto, and all rights of renewal and extension if any relating thereto on a worldwide basis, as of the Effective Date.

The Assignor further confirms the transfer and assignment to the Assignee of the right to sue for past infringement, to institute or continue opposition and cancellation proceedings or other legal proceedings and to recover and retain all damages and profits arising in connection with such Trademarks.

The Assignor undertakes to, upon the written request of the Assignee, execute all papers, make all rightful oaths, testify on behalf of the Assignee, and do all other acts necessary to carry out the intent of this Agreement, as well as to provide such other material, information and/or assistance as the Assignee may consider necessary.

This Agreement shall be binding upon the parties, their successors and/or assigns, and all others acting by, through, with or under their direction and all those in privity therewith.

This Agreement is governed by, and shall be construed and interpreted in accordance with the laws of the Province of Québec and the federal laws of Canada, applicable therein, without regard to conflict of law principles. It is the express wish of the parties hereto that this Agreement be drawn up in English. La volonté expresse des parties aux présentes est que ce document soit rédigé en anglais.




