**RELEASE OF SECURITY INTEREST**

This Release of Security Interest is made as of December 30, 2020, by **PACIFIC WESTERN BANK**, a California state chartered bank ("**Bank**"), in favor of GLOBALWEBINDEX HOLDINGS LIMITED, a limited company registered in England and Wales ("**Parent**"), TRENDSTREAM LIMITED, a limited company registered in England and Wales ("**Trendstream**"), GLOBALWEBINDEX LIMITED, a limited company registered in England and Wales ("**GWI Limited**"), GLOBALWEBINDEX INC., a Delaware corporation ("**GWI Inc.**"), and GLOBALWEBINDEX LABS LIMITED, a limited company registered in England and Wales ("**Labs**", and together with Parent, Trendstream, GWI Limited, and GWI Inc., collectively, "**Grantors**," and each, a "**Grantor**").

Recitals
