TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement (the "Agreement") is made as of July 31, 2020 (the "Effective Date"), by and between ArtSkills, Inc., a Pennsylvania corporation (the "Assignor"), and Dollar General Corporation, a Tennessee corporation (the "Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Master Supply Agreement dated July 16, 2018 (the "MSA"); and

WHEREAS, pursuant to the MSA, Assignor agreed to assign to Assignee, and Assignee agreed to accept, all right, title and interest in the trademarks, CRAFTER'S CLOSET (stylized logo), U.S. Reg. No. 6,084,306, and CRAFTER'S CLOSET (word mark), U.S. Reg. No. 6,084,313, and any formatives, variants, and other common law rights arising from use of the foregoing in connection with art, craft and creative supplies (collectively, the "Marks").

NOW, THEREFORE, in consideration of the mutual promises and obligations contained below, the sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby conveys, transfers, and assigns to the Assignee all of the Assignor's right, title, and interest of whatever kind in the Marks, together with (a) the goodwill relating to the products and services with which the Marks have been used, (b) all income, royalties, and damages hereafter due or payable to the Assignor with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks, and (c) all rights to sue for past, present and future infringement or misappropriations of the Marks.
2. Assignor represents and warrants that: (a) it has not pledged, assigned, or otherwise encumbered the Marks, and there are no liens on the Marks; (b) it has not granted any rights in or ownership of the Marks, or in other marks that would be confusingly similar, to any other party; and (c) there are no pending or threatened third party or governmental actions involving the Mark.
3. Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the mark and its related property.
4. The Assignee hereby accepts the assignment of such ownership and rights from the Assignor.
