## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (this "Trademark Assignment") is made and entered into as of December 11, 2020 ("Effective Date"), by and between Lock and Lube LLC ("Assignor") and Isles Bridge LLC ("Assignee").

**WHEREAS**, Assignor owns the trademark identified in Schedule I to this Trademark Assignment (the "Mark");

**WHEREAS**, pursuant to the terms of a certain Asset Purchase Agreement dated March 17, 2017 (the "Purchase Agreement") by and between Assignor and Assignee, Assignor agreed to assign to Assignee all of Assignor's right, title, and interest in and to the Mark, together with the goodwill associated therewith;

**WHEREAS**, in connection with the Purchase Agreement, the Assignor agreed to transfer substantially all of the assets of the business to which the Mark relates, and that business is ongoing;

**WHEREAS**, Section 2.5 of the Purchase Agreement provides that after the closing called for by that agreement, Assignor will execute and deliver to Assignee other instruments of conveyance and transfer as Assignee may reasonably require to put Assignee in full possession of the assets purchased by Assignee pursuant to the Purchase Agreement (the "Purchased Assets").

**WHEREAS**, the Purchased Assets include the Mark, and assignment of the Mark from Assignor to Assignee pursuant to this Trademark Assignment is required to put Assignee in full possession of the Mark; and

**NOW THEREFORE**, pursuant to Section 2.5 of the Purchase Agreement, and for good and valuable consideration as set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, conveys, assigns to Assignee, its successor and assigns, in connection with the transfer of the assets of the business to which the Mark pertains, Assignor's entire right, title and interest in and to the Mark, including, without limitation, all registrations and applications therefore; all applications and registrations in any foreign countries and all applications and registrations claiming priority therefrom; the right to apply for and register the Mark in the United States of America and all foreign countries, together with the goodwill of Assignor's business in which the Mark is used and symbolized by the Mark; all common law and statutory rights related thereto, all rights of renewal and extension, and the right to sue for and recover for damages and profits for past infringement thereof.
