WITNESSETH

WHEREAS, Assignor is the owner of the trademarks and trademark applications and registrations set forth on Schedule A attached hereto, and incorporated herein by reference (the "Marks");

WHEREAS, Assignor desires to convey, transfer, and assign to Assignee the Marks, and has agreed to execute and deliver this Trademark Assignment, for recording with the United States Patent and Trademark Office, the European Union Intellectual Property Office, and corresponding entities or agencies in all other applicable jurisdictions; and

WHEREAS, the Parties desire to enter into this Assignment to affect the transfer of all right, title, and interest in and to the Marks to Assignee (but excluding the same for the country of Argentina, in which Assignor shall maintain ownership of all right, title, and interest in the Marks).

NOW, THEREFORE, for and in consideration of the premises and the mutual promises hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Transfer and Assignment. Assignor hereby irrevocably transfers and assigns to Assignee all right, title, and interest in and to:
 - a. the Marks and all issuances, extensions, and renewals thereof, all of the goodwill associated therewith held by Assignor (but excluding the same for the country of Argentina, in which Assignor shall maintain ownership of all right, title, and interest in the Marks);
 - b. all rights of any kind whatsoever of Assignor accruing under any of the Marks provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world (but excluding the same for the country of Argentina, in which Assignor shall maintain ownership of all right, title, and interest in the Marks); and
 - c. the right to recover for damages and profits and other remedies for past infringements of the Marks, as well as any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any of the Marks (but excluding the same for the country of Argentina, in which Assignor shall maintain ownership of all right, title, and interest in the Marks).
2. Further Documentation and Actions. Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments, and to do any and all further reasonable and necessary acts to vest in Assignee all right, title, and interest in and to the Marks, and to enable such right, title, and interest for the Marks to be recorded in the United States Patent and Trademark Office, the European Union Intellectual Property Office, and corresponding entities or agencies in all other applicable jurisdictions, for no additional compensation.



3. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the Parties and their respective successors and assigns.
