**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of December 30, 2020, by Ares Capital Corporation, as Administrative Agent ("Grantee") in favor of D4C Dental Brands, Inc. (the "Grantor").

W I T N E S S E T H:

WHEREAS, the Grantor, the other grantors party thereto and the Grantee entered into that certain Security Agreement dated as of December 21, 2016 (as amended, restated, supplemented or modified from time to time, the "Security Agreement"), pursuant to which Grantor, to secure the Secured Obligations, granted a continuing security interest in or other Lien on substantially all the assets of Grantor, including all of Grantor's right, title and interest in, to and under certain Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, the Grantor and Grantee entered into that certain Trademark Security Agreement dated as of December 21, 2016 (the "Trademark Security Agreement"; capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on December 30, 2016, at Reel 5954, Frame 0270; and

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases the entirety of its security interest in all of Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"):

- (i) all of its Trademarks, including, without limitation, those referred to on Schedule A hereto;
- (ii) all renewals and extensions of the foregoing;
- (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Grantee hereby terminates the Trademark Security Agreement and reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Trademark Collateral, and authorizes the recordation of this Trademark Release with the United States Patent and Trademark Office at the expense of the Grantor.




