**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of December 16, 2020, by COMERICA BANK, (the "Secured Party") in favor of NATURE'S BAKERY, LLC (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Revolving Credit, Term Loan and Specific Advance Facility Agreement, dated as of August 18, 2016, (the "Loan Agreement"), Grantor granted a security interest to the Secured Party in certain intangible property;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of August 18, 2016, among the Secured Party and Grantor (the "Intellectual Property Security Agreement"), Grantor, by reference to the Loan Agreement, reaffirmed its intent to grant a security interest to the Secured Party specifically in certain Intellectual Property Collateral (as that term is defined in the Intellectual Property Security Agreement), including certain Trademarks (as that term is defined in the Intellectual Property Security Agreement);

WHEREAS, the Intellectual Property Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 18, 2016 at Reel 5859 and Frame 0096;

WHEREAS, the Secured Party now desires to terminate and release the entirety of its security interest granted pursuant to the Intellectual Property Security Agreement (the "Secured Interest");

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby agrees as follows:

1. Definitions. All initially capitalized terms used herein without definition shall have the meanings ascribed to them in the Loan Agreement or the Intellectual Property Security Agreement, as applicable.
2. Release of Security Interest. The Secured Party hereby terminates, releases and discharges the entirety of its security interest and mortgage in the Intellectual Property Collateral, including the Trademarks set forth on Schedule I attached hereto. Any right, title, or interest of the Secured Party in such Intellectual Property Collateral shall hereby cease and become void.
3. Further Assurances. At the expense of the Grantor, the Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case, as may be reasonably necessary to effect the release of the Secured Interest.
4. California Law. This Termination and Release shall be governed by the laws of the State of California, without regard for choice of law provisions.
