**TERMINATION AND RELEASE OF
GRANT OF A SECURITY INTEREST – TRADEMARKS**

This Termination and Release of Grant of a Security Interest – Trademarks (this “Termination”), dated as of December 29, 2020, is executed by TC Lending, LLC, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the “Grantee”), and in favor of Gainsight, Inc., a Delaware corporation (“Grantor”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Grant of Security Interest – Trademarks, dated as of July 29, 2019 (as amended, the “Security Agreement”), executed by Grantor in favor of Grantee, Grantor granted to Grantee a security interest in the Trademark Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 30, 2019, at Reel 6707 and Frame 0445, to evidence the security interest granted under the Security Agreement.

C. Grantee agrees to terminate and release its security interest in the Trademark Collateral specified below and authorizes Grantor to file this Termination with respect to such release of its security interest as herein provided.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee hereby agrees as follows:

(a) Grantee expressly terminates and releases its security interest in all of Grantor’s right, title and interest in, to and under the following (collectively, the “Trademark Collateral”):

(i) trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are issued or applied for in the United States Patent and Trademark Office, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, other than any Excluded Assets.

(b) Grantee authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.
