**Articles of Merger
of
Kwantek, LLC, a Kentucky limited liability company
(the Merging Company)
with and into
Team Software, Inc., a Nebraska corporation
(the Surviving Corporation)**

Pursuant to Section 21-2,166 of the Nebraska Model Business Corporation Act (the "Act"), Team Software, Inc., a Nebraska corporation, and Kwantek, LLC, a Kentucky limited liability company, adopt the following Articles of Merger:

1. **Names.** The names and jurisdictions of incorporation of each constituent organization are set forth below:

Kwantek, LLC, a Kentucky limited liability company (the "Merging Company"); and

Team Software, Inc., a Nebraska corporation (the "Surviving Corporation").

2. **Surviving Corporation.** The name and jurisdiction of the Surviving Corporation is Team Software, Inc., a Nebraska corporation.

3. **Surviving Articles:** The Articles of Incorporation of the Surviving Corporation, as in effect immediately prior to the effective time of the merger, shall be the Articles of Incorporation of the Surviving Corporation and in full force and effect from and after the effective time of the merger.

4. **Approval.** The Agreement and Plan of Merger setting forth the terms and conditions of the merger was duly approved, as to the Merging Company, by the sole member of the Merging Company in the manner required by the Kentucky Limited Liability Company Act and the articles of organization of the Merging Company. Pursuant to Section 21-2,164(8) of the Act, the approval of the shareholders of the Surviving Corporation was not required.

5. **Effective Time.** These Articles of Merger shall be effective on December 31, 2020 at 10:59 p.m. Central Time.

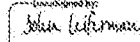
