RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), dated as of December 31, 2020, is made by CIBC BANK USA (f/k/a THE PRIVATE BANK AND TRUST COMPANY), an Illinois banking corporation, as administrative agent (in such capacity, together with its successors and assigns, “Assignor”), in favor of TTE FILTERS, LLC, a New York limited liability company (“TTE”), and GOWANDA-GEC, LLC, a New York limited liability company (“GEC” and collectively with TTE, the “Assignees” and each individually, an “Assignee”). Capitalized terms used in this Release and not otherwise defined herein shall have the meanings set forth in the Trademark Security Agreement (as defined below).

WHEREAS, the Assignees and Assignor, entered into that certain Security Agreement (Subsidiary), dated as of May 19, 2016 (as it may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, each Assignee executed and delivered to Assignor a Trademark Security Agreement, dated as of May 19, 2016 (the “Trademark Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded on May 26, 2016 with the U.S. Patent and Trademark Office, at Reel 5800 / Frame 0577;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Assignee granted to Assignor, on behalf of and for the ratable benefit of itself and the Lenders, a security interest (the “Security Interest”) in all of its right, title and interest in and to, the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks listed on Schedule 1; and

WHEREAS, Assignor desires to release its interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby, without any representation, warranty or recourse, (i) releases and discharges all right, title and interest in the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule 1 hereto and (ii) terminates the Trademark Security Agreement. Any right, title or interest of Assignor in the Trademark Collateral shall hereby cease and become void. Assignor authorizes the recordation of this Release with the U.S. Patent and Trademark Office and hereby agrees to execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Assignee. This Release shall be construed in accordance with and governed by the laws of the State of New York.
