**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of January 4, 2021 by **SILICON VALLEY BANK**, as Administrative Agent, a California corporation, with a loan production office located at 3003 Tasman Drive HF 150, Santa Clara, California 95054 ("**Bank**"), in favor of **SIGMATEK SYSTEMS, LLC**, a Delaware limited liability company, formerly an Ohio limited liability company (the "**Grantor**").

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of October 12, 2018, (the "**Agreement**"), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office ("**USPTO**") on October 12, 2018 at Reel 6505, Frame 0647.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor's right, title and interest in, to and under the Trademarks, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto;
2. authorizes and requests that this Termination and Release be recorded with the USPTO; and
3. **THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.**
