## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of January 4, 2021 (“Effective Date”), by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, a national banking association, in its capacity as notes collateral agent for the Secured Parties (in such capacity, “Agent”), in favor of **BMC STOCK HOLDINGS, INC.**, a Delaware corporation (“Parent”), **BMC CORPORATE SERVICES, LLC**, a Delaware limited liability company, **BMC EAST, LLC**, a North Carolina limited liability company, formerly known as Stock Building Supply of Arkansas, LLC, **BMC PROCUREMENT, LLC**, a Delaware limited liability company, **BMC TEXAS SALES, LLC**, a Delaware limited liability company, **BMC WEST, LLC**, a Delaware limited liability company, formerly known as BMC West Corporation, ProCon Construction Services, LLC, Trussmart Building Components, LLC and VNS Corporation, and **BMC WINDOW & DOOR SOUTHEAST, LLC**, a Delaware limited liability company and **SELECTBUILD CONSTRUCTION, INC.**, a Delaware corporation (collectively, the “Grantors”).

**WHEREAS**, reference is made to that certain Security Agreement, dated as of September 15, 2016, by and among the Grantors, Agent and certain other parties thereto (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, amended and restated, supplemented, or otherwise modified, the “Security Agreement”);

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of September 15, 2016 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on September 16, 2016 at Reel/Frame 5878/0751 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, collectively, the “Trademark Security Agreement”), the Grantors granted to Agent, for the benefit of the Secured Parties, a continuing first priority security interest in all of the Grantors’ right, title and interest in, to and under the Trademark Collateral, whether then existing or thereafter created or acquired, including the trademarks listed therein (the “Trademarks”); and

**WHEREAS**, Grantors now desire that the Agent release its security interest in the Trademarks, including, without limitation, the trademarks listed on Schedule 1 hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. All initially capitalized terms used herein (including the preamble and recitals hereof) without definition shall have the meanings assigned to such terms in the Trademark Security Agreement or, if not defined therein, the Security Agreement.

2. Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest in the Trademarks granted pursuant to the Security Agreement and the Trademark Security Agreement, and reassigns to the Grantors all right, title and interest of Agent in, to and under the Trademarks, including the items listed on Schedule 1.

3. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors’ expense, as may be reasonably necessary to effect the release of the security interest in the Trademarks contemplated hereby.



