TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of January 1, 2021 (“Effective Date”), by **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company, formerly known as Wells Fargo Foothill, LLC (“WFCF”), in its capacity as agent for the Secured Parties (in such capacity, “Agent”), in favor of **BMC STOCK HOLDINGS, INC.**, a Delaware corporation, formerly known as Building Materials Holding Corporation, Stock Building Supply Holdings, Inc. and Stock Building Supply Holdings II, LLC (“Parent”), **BMC CORPORATE SERVICES, LLC**, a Delaware limited liability company, **BMC EAST, LLC**, a North Carolina limited liability company, formerly known as Stock Building Supply LLC, Stock Building Supply Midwest, LLC and Stock Building Supply of Arkansas, LLC, **BMC PROCUREMENT, LLC**, a Delaware limited liability company, **BMC TEXAS SALES, LLC**, a Delaware limited liability company, **BMC WEST, LLC**, a Delaware limited liability company, formerly known as BMC West Corporation, ProCon Construction Services, LLC, Trussmart Building Components, LLC and VNS Corporation, BMCW SouthCentral, L.P. and Knipp Brothers Industries, LLC, **BMC WINDOW & DOOR SOUTHEAST, LLC**, a Delaware limited liability company and **SELECTBUILD CONSTRUCTION, INC.**, a Delaware corporation, formerly known as BMC Framing, Inc. and BMC Construction, Inc. (collectively, the “Grantors”).

WHEREAS, reference is made to (i) that certain Security Agreement, dated as of June 30, 2009, by and among the Grantors, Agent and certain parties thereto (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “2009 Security Agreement”) and (ii) that certain Second Amended and Restated Security Agreement, dated as of December 1, 2015, by and among the Grantors, Agent and certain other parties thereto (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “2015 Security Agreement,” and together with the 2009 Security Agreement, the “Security Agreements”);

WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of June 30, 2009 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on July 6, 2009 at Reel/Frame 004017/0082, (ii) that certain Amendment Number One to Trademark Security Agreement, dated as of April 2, 2010 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on April 5, 2010 at Reel/Frame 004180/0354, (iii) that certain Amendment to Trademark Security Agreement, dated as of December 1, 2015 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on December 2, 2015 at Reel/Frame 005681/0457, (iv) that certain Amendment Number Three to Trademark Security Agreement, dated as of January 14, 2016 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on February 12, 2016 at Reel/Frame 005730/0893, (v) that certain Trademark Security Agreement, dated as of January 4, 2010 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on January 5, 2010 at Reel/Frame 004124/0945, (vi) that certain IP Supplement, dated January 6, 2010 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on February 12, 2010 at Reel/Frame 004149/0234, (vii) that certain Amendment to Trademark Security Agreement, dated as of September 20, 2013 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on September 20, 2013 at Reel/Frame 005115/0292, (viii) that certain Amendment to Trademark Security Agreement, dated June 1, 2015 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on June 2, 2015 at Reel/Frame 005538/0880, (ix) that certain Amendment to Trademark Security Agreement, dated as of December 1, 2015 by and among Agent and the Grantors, and recorded with the United States Patent and Trademark Office on December 2, 2015 at Reel/Frame 005681/0466, (x) that certain Amendment to Trademark Security Agreement, dated as of January 16, 2016 by and among Agent and the Grantors, and recorded with

the United States Patent and Trademark Office on February 12, 2016 at Reel/Frame 005731/0159 (in each case, as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, collectively, the “Trademark Security Agreements”), the Grantors unconditionally granted, assigned and pledged to Agent, for the benefit of the Secured Parties and each member of the Lender Group and each of the Bank Product Providers, to secure the Secured Obligations, a continuing security interest in all of the Grantors’ right, title and interest in, to and under the Trademark Collateral or Additional Trademark Collateral, including the trademarks listed therein (the “Trademarks”); and

WHEREAS, Agent now desires to release its security interest in the Trademarks, including, without limitation, the trademarks and trade names listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. All initially capitalized terms used herein (including the preamble and recitals hereof) without definition shall have the meanings assigned to such terms in the Trademark Security Agreements or, if not defined therein, the Security Agreements.

2. Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest in the Trademarks granted pursuant to the Security Agreements and the Trademark Security Agreements, and reassigns to the Grantors all right, title and interest of Agent in, to and under the Trademarks, including the items listed on Schedule 1.

3. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors’ expense, as may be reasonably necessary to effect the release of the security interest in the Trademarks contemplated hereby.





