WORLDWIDE IP ASSIGNMENT AGREEMENT

This IP Assignment Agreement (the “**Agreement**”) is made as of November 6, 2020 (“**Effective Date**”) by and between **THE MUSIC PEOPLE, INC.**, a Connecticut corporation with a principal place of business at 154 Woodlawn Road, Suite C, Berlin, Connecticut, 06037, United States of America (“**Assignor**”) and **JAM INDUSTRIES USA, LLC**, a Delaware limited liability company with a principal place of business at 310 West Newberry Rd. Bloomfield, CT 06002, United States of America (“**Assignee**”).

WHEREAS, Assignor is the owner of all right, title, and interest in and to the intellectual property assets listed in the attached Schedule “A” (“**IP Assets**”);

WHEREAS, this Agreement is entered into pursuant to an Asset Purchase Agreement between Assignor, Assignee and the other parties thereto (the “**APA**”);

WHEREAS, Assignee wishes to acquire the IP Assets and all right, title, and interest in and to the IP Assets, and Assignor wishes to assign the IP Assets and all right, title and interest in and to the IP Assets to the Assignee;

NOW THEREFORE, for good and valuable consideration and the sum of One Dollar (\$1.00USD), the receipt and sufficiency of which is acknowledged by Assignor:

1. Assignor hereby assigns to Assignee, its successors and assigns, Assignor’s entire right, title and interest in and to the IP Assets, whether registered or unregistered, in association with all inventions and goods and services in respect of which the IP Assets pertain to, or may have been used, together with the goodwill therewith, including all causes of action for and the right to sue in respect of all infringements of the IP Assets, which may have occurred before the effective date of this Agreement, and the right to all remedies including damages, an accounting of profits, or other proceeds in respect of such infringements.
2. Assignor agrees to execute and deliver any documents, and to take such actions, as may be reasonably requested by Assignee, its successors or assigns, to give

full effect to this Agreement and to vest, perfect, confirm, record or otherwise reflect or give effect to Assignee's rights as set forth herein.

3. The terms and provisions of this Agreement shall extend to, enure to the benefit of, and shall be binding upon the parties, their directors, and any successors, assigns, subsidiaries, affiliates, licensees, or related companies owned or otherwise controlled by the parties.
4. This Agreement shall be governed, construed, and interpreted in accordance with the laws of the State of Delaware, without regard to any conflict of law principles. Each party irrevocably agrees that any legal action or proceeding arising out of or relating to this Agreement shall be brought and determined in the federal courts located in the State of Delaware or in the Delaware Chancery Court or any other state court of the State of Delaware, and the appellate courts having jurisdiction of appeals from such courts. Each party hereby irrevocably submits to the exclusive jurisdiction of the aforesaid courts for itself and with respect to its property, generally and unconditionally, with regard to any such action or proceeding arising out of or relating to this Agreement and the transactions contemplated in this Agreement.
5. This Agreement, along with the APA, constitute the entire agreement between the parties relating to the subject matter hereof and supersedes all prior agreements, understandings and representations concerning such subject matter. This Agreement may not be modified except in writing, signed by both parties.
6. If a provision of this Agreement is prohibited or invalidated under applicable law, the remainder of the Agreement shall remain unaffected.
7. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which, together, shall constitute one and the same instrument.
