Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, Transport Service Co., a Delaware corporation, hereby certifies the following information relating to the merger of Transport Service Co., an Illinois corporation, with and into Transport Service Co., a Delaware corporation:

**First:** The name of the surviving corporation is Transport Service Co., a Delaware corporation, and the name of the corporation being merged into the surviving corporation is Transport Service Co., an Illinois corporation.

**Second:** The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent entities pursuant to Title 8, Section 252 of the Delaware General Corporation Law.

**Third:** The name of the surviving corporation is Transport Service Co., a Delaware corporation.

**Fourth:** The certificate of incorporation of the surviving corporation shall be its certificate of incorporation.

**Fifth:** The authorized stock and par value of the non-Delaware corporation is 800,000 shares, consisting of 400,000 shares of voting common stock (\$.10 par value per share) and 400,000 shares of non-voting common stock (\$.10 par value per share).


**Sixth:** The merger is to become effective on December 31, 2013 at 11:59 p.m.

**Seventh:** The Agreement of Merger is on file at the offices of the surviving corporation: 4366 Mt. Pleasant Street, N.W., North Canton, Ohio 44720.

**Eighth:** A copy of the Agreement of Merger will be furnished by the surviving corporation, on request without cost, to any stockholder of the constituent corporations.
