Pursuant to Section 266 of the Delaware General Corporation Law (the “DGCL”) and Section 18-214 of the Delaware Limited Liability Company Act, the undersigned, acting as an authorized officer on behalf of CafePress Inc., a Delaware corporation (the “Company”), hereby executes this Certificate of Conversion from Corporation to Limited Liability Company (this “Certificate”) to convert the Company into a Delaware limited liability company. The undersigned certifies as follows:

1. The Company was originally formed as a Delaware corporation on January 19, 2005.
2. Immediately prior to the filing of this Certificate, the name of the Company was “CafePress Inc.”
3. Concurrently with the filing of the Certificate, (i) a Certificate of Formation will be filed with the Delaware Secretary of State on behalf of the Company, and (ii) the name of the Company will be changed to “CafePress LLC”.
4. The conversion of the Company into a Delaware limited liability company has been approved by the board of directors and the sole stockholder of the Company in accordance with Section 266 of the DGCL.
