- (f) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

3. Agreement to Perform Necessary Acts. Assignor agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement for a period not to exceed one hundred twenty (120) days.

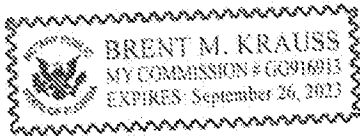

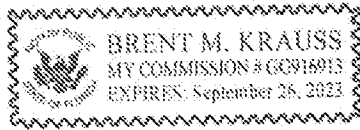


