CONFIRMATION OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Confirmation of Release of Security Interest in Trademarks, dated December 2, 2020 ("Confirmation of Release") is made by and between Chicken Soup for the Soul Entertainment, Inc., a Delaware corporation ("CSSE") and Patriot Bank, N.A. ("Patriot", and together with CSSE, the "Parties").

WHEREAS, pursuant to that certain Loan and Security Agreement ("Loan Agreement") dated as of April 27, 2018, by and among Patriot, on the one hand, and CSSE, Screen Media Ventures, LLC, a Delaware limited liability company, BD Productions, LLC, a Connecticut limited liability company, 757 Film Acquisition LLC, a Delaware limited liability company, and Screen Media Films, LLC, a Delaware limited liability company, on the other hand (collectively, the "Grantors"), the Grantors executed and delivered to Patriot that certain Intellectual Property Security Agreement dated as of April 27, 2018 (the "IP Security Agreement");

WHEREAS, pursuant to the IP Security Agreement, Patriot was granted security interests in and to the trademarks set forth on Exhibit A hereto (the "Collateral"), which security interests were recorded at the United States Patent and Trademark Office on April 30, 2018, at Serial Nos. 87724712, 87138643, 87082464, and 87083312 (the "USPTO Filings");

WHEREAS, each of the Loan Agreement and IP Security Agreement were amended and restated as of August 22, 2019 to, among other things, combine and consolidate the term loan and line of credit under the Loan Agreement into a new term loan, and to add additional Grantors and additional Collateral;

WHEREAS, each of the Loan Agreement and IP Security Agreement, each as amended, terminated on or about July 17, 2020 ("Termination Date") upon the payment in full of all Obligations and Guaranteed Obligations (as such terms are defined in the Loan Agreement); and

WHEREAS, in connection with the termination of the Loan Agreement and IP Security Agreement, each as amended, by letter agreement dated July 20, 2020, Patriot agreed to execute any releases and terminations of security interests in the Collateral as prepared by a Grantor.


NOW, THEREFORE, the Parties state as follows:

1. Confirmation of Release of Security Interest. Patriot's rights in the Collateral under the IP Security Agreement, as amended, as set forth in the USPTO Filings terminated on the Termination Date. Patriot hereby authorizes the recordation of this Confirmation of Release against the USPTO Filings as confirmation of such release.
2. Governing Law. This Confirmation of Release shall be governed by and construed in accordance with the internal laws of the State of Connecticut, without regard to the conflicts of law principles thereof.


