CONFIRMATION OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Confirmation of Release of Security Interest in Trademarks, dated December 2, 2020 ("Confirmation of Release") is made by and between Chicken Soup for the Soul Entertainment, Inc., a Delaware corporation ("CSSE") and Patriot Bank, N.A. ("Patriot", and together with CSSE, the "Parties").

WHEREAS, pursuant to that certain Amended and Restated Loan and Security Agreement ("Loan Agreement") dated as of August 22, 2019, by and among Patriot, on the one hand, and CSSE, Screen Media Ventures, LLC, a Delaware limited liability company, BD Productions, LLC, a Connecticut limited liability company, 757 Film Acquisition LLC, a Delaware limited liability company, Screen Media Films, LLC, a Delaware limited liability company, Pivotshare, Inc., a Delaware corporation, A Sharp Inc., a Delaware corporation, and Crackle Plus, LLC, a Delaware limited liability company, on the other hand (collectively, the "Grantors"), the Grantors executed and delivered to Patriot that certain Amended and Restated Intellectual Property Security Agreement dated August 22, 2019 (the "IP Security Agreement");

WHEREAS, pursuant to the IP Security Agreement, Patriot was granted security interests in and to the trademarks set forth on Exhibit A hereto (the "Collateral"), which security interests were recorded at the United States Patent and Trademark Office on August 22, 2019, at Registration Nos. 5764609, 5728284, 5740140, 5740139, 4893420, 4655928, 4649301, 4399612, 4045201, 5020861, 4543876, 4548004, 5833745, and Serial Nos. 88273535, and 88273560 (the "USPTO Filings");

WHEREAS, each of the Loan Agreement and IP Security Agreement terminated on or about July 17, 2020 ("Termination Date") upon the payment in full of all Obligations and Guaranteed Obligations (as such terms are defined in the Loan Agreement); and

WHEREAS, in connection with the termination of the Loan Agreement and IP Security Agreement, by letter agreement dated July 20, 2020, Patriot agreed to execute any releases and terminations of security interests in the Collateral as prepared by a Grantor.


NOW, THEREFORE, the Parties state as follows:

1. Confirmation of Release of Security Interest. Patriot's rights in the Collateral under the IP Security Agreement as set forth in the USPTO Filings terminated on the Termination Date. Patriot hereby authorizes the recordation of this Confirmation of Release against the USPTO Filings as confirmation of such release.
2. Governing Law. This Confirmation of Release shall be governed by and construed in accordance with the internal laws of the State of Connecticut, without regard to the conflicts of law principles thereof.

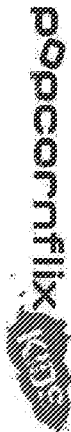
