TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (“**Release**”) is made as of December 9, 2020, by BMO HARRIS BANK N.A., in its capacity as Administrative Agent for itself and the other Lender Parties (“**Grantee**”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the TM Security Agreements (as defined below).

WITNESSETH:

WHEREAS, Spectrio LLC, a Delaware limited liability company (“**Grantor**”) and Grantee are party to that certain Trademark Security Agreement dated as of September 15, 2017 (the “**2017 Agreement**”), that certain Trademark Security Agreement dated as of February 9, 2018 (the “**February 2018 Agreement**”), that certain Trademark Security Agreement dated as of August 3, 2018 (the “**August 2018 Agreement**”), that certain Trademark Security Agreement dated as of November 30, 2018 (the “**November 2018 Agreement**”), that certain Trademark Security Agreement dated as of August 10, 2020 (the “**2020 Agreement**”; the 2017 Agreement, February 2018 Agreement, August 2018 Agreement, November 2018 Agreement and the 2020 Agreement, collectively the “**TM Security Agreements**”) pursuant to which the Grantor granted a security interest to Grantee for the benefit of itself and the other Lender Parties in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Lender Parties, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the 2017 Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 15, 2017 at Reel 6155 Frame 0965;

WHEREAS, the February 2018 Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on February 9, 2018 at Reel 6268 Frame 0209;

WHEREAS, the August 2018 Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 3, 2018 at Reel 6404 Frame 0302;

WHEREAS, the November 2018 Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on November 30, 2018 at Reel 6491 Frame 0504;

WHEREAS, the 2020 Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 10, 2020 at Reel 7023 Frame 0148; and

WHEREAS, the Grantor have requested that Collateral Agent release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Collateral**”):

- (i) all of its Trademarks, including the Trademark registrations and pending applications for registration in the U.S. Patent and Trademark Office listed on Schedule A hereto;
- (ii) all renewals, modifications and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(iv) all income, royalties, damages and payments now and hereafter due or payable at any time due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, including, without limitation, the right to sue for past, present and future infringements and dilutions thereof.

2. Grantee hereby (a) reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Trademarks and the Trademark Collateral, (b) terminates and releases the TM Security Agreements in their entirety.

3. This Release and the rights and obligations of the parties hereunder shall be construed in accordance with and be governed by the laws of the State of New York.

4. The Grantee understands and agrees that this Release may be recorded by or for each Grantor with the U.S. Patent and Trademark Office, and hereby authorizes each Grantor to record this Release with the U.S. Patent and Trademark Office.
