## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of January 8, 2021, by RAYTHEON COMPANY, a Delaware corporation (the “**Secured Party**”), in favor of FORCEPOINT LLC, a Delaware limited liability company (the “**Grantor**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantor and the Secured Party are party to that certain Trademark Security Agreement Supplement, dated as of February 10, 2020 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the Trademark Security Agreement, Grantor granted to the Secured Party a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Schedule I hereto:

WHEREAS, the Trademark Security Agreement was recorded on February 27, 2020 with the United States Patent and Trademark Office at Reel/Frame 6877/0209; and

WHEREAS, the Grantor has requested that the Secured Party execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby irrevocably releases and terminates its security interest in the Trademark Collateral, and re-assigns and re-conveys to the Grantor any and all right, title or interest the Secured Party may have in, to or under the Trademark Collateral.
