**PATENT AND TRADEMARK SECURITY AGREEMENT**

**GRANT OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS AND PATENTS**

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Tuesday Morning Partners, Ltd., a Texas limited partnership, (“TMP”) and Tuesday Morning, Inc., a Texas corporation, (in such capacity, together with TMP, the “Grantors”) hereby grant, on this 31st day of December 2020, to Alter Domus (US) LLC, as Administrative Agent, with offices at 225 W. Washington St., 9th Floor, Chicago, Illinois 60606, (the “Grantee”), a security interest in all of the following included in the Collateral (as defined in the Security Agreement referred to below) (i) each of the Grantor’s right, title and interest in and to the United States trademark registrations and trademark applications set forth on Schedule A attached hereto (the “Marks”), (ii) each of the Grantor’s right, title and interest in and to the United States patents and patent applications set forth on Schedule B attached hereto (the “Patents”), in each case together with (iii) all Proceeds (as such term is defined in the Security Agreement referred to below) of the Marks and Patents.

THIS GRANT is made to secure the full and prompt performance and payment of all the Secured Obligations (as such term is defined in the Security Agreement described below).


This Grant has been granted in conjunction with the security interest granted to the Grantee under that certain Guarantee and Collateral Agreement among the Grantors, the other grantors party thereto and the Grantee, dated as of December 31, 2020 (as amended, amended and restated or otherwise modified from time to time, the “Security Agreement”). The rights and remedies of the Grantee with respect to the security interest granted herein are more fully set forth in the Security Agreement. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

*Notwithstanding anything herein to the contrary, the lien and security interest granted to Grantee pursuant to this Patent and Trademark Security Agreement and the exercise of any right or remedy by Grantee hereunder or with respect thereto are subject to the provisions of that certain Intercreditor Agreement dated as of December 31, 2020, by and among Grantee, in its capacity as Term Loan Representative, JPMorgan Chase Bank, N.A., in its capacity as ABL Representative, and Grantor.*


