WHEREAS, Assignor has been the owner of the **POWERVISION CONFIGURATION STUDIO** trademark and the associated registration and application therefor as represented by U.S. Registration No. 4256900 (the "Mark"), together with the goodwill of the business symbolized thereby in connection with the goods and services on and for which the Mark is used (the "Product").

WHEREAS, Assignor, by and through its predecessor in interest, namely by and through EControls, Inc., a Texas Corporation, which later changed its name to EControls Group, Inc., which transferred all of its remaining trademarks to Assignor, had previously attempted and desired to convey, transfer, assign, deliver, and contribute to Assignee all right, title and interest in and to the Mark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers, and contributes, and confirms that it has conveyed, transferred, assigned, delivered, and contributed to Assignee all of Assignor's right, title, and interest of whatever kind in and to the Mark, together with:

(i) the goodwill of the business relating to the Product in respect upon which the Mark is used and for which it is registered;

(ii) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark, including, without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and

(iii) all rights to sue for past, present and future infringement, or misappropriation of the Mark.




