NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment (“**Assignment**”) is entered into as of January 11, 2021 (the “**Effective Date**”) and is entered into by and between Aramark Refreshment Services, LLC, a Delaware limited liability company with a place of business at 2400 Market Street, Philadelphia, PA 19103 (“**Assignor**”), and Aramark Services, Inc., a Delaware corporation with a place of business at 2400 Market Street, Philadelphia, PA 19103 (“**Assignee**”). Assignor and Assignee are hereby referred to collectively as the “**Parties**” and individually as a “**Party**”.

WHEREAS, as of the Effective Date, Assignor transferred, granted, conveyed, and assigned to Assignee Assignor’s right, title, and interest in and to the trademark and trademark registration and service mark and service mark registration appearing on **Schedule A** and all goodwill associated with the trademarks (hereinafter the “**Marks**”); and

WHEREAS, the Parties wish to memorialize in writing and for recordation before the United States Patent and Trademark Office the assignment of the Marks from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

1. Assignor hereby assigns, transfers, and conveys to Assignee, and Assignee hereby accepts, in each case as of the Effective Date, all of Assignor’s rights, title and interest in, under, and to the Marks (including the registrations identified on **Schedule A**), together with the goodwill associated with and symbolized by such Marks, the same to be held by Assignee for Assignee’s (and Assignee’s successors’, assigns’, and other legal representatives’) own use and enjoyment, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made. The foregoing assignment includes the right for Assignee to sue for and collect damages arising out of or under the past, present, or future infringement, misappropriation and/or dilution of the Marks, all rights to royalties, and license fees, if any, deriving from the Marks, and the right for Assignee to file, secure, and maintain applications and registrations for the Marks in Assignee’s name.
2. From and after the date hereof, Assignor shall execute and deliver such additional documents, instruments, conveyances, and assurances, and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment. Without limiting the foregoing, Assignor shall execute and deliver to Assignee such assignments and other documents, certificates, and instruments as may be reasonably necessary to record and perfect the Assignment. Assignee shall be responsible for filing the Assignment, and other documents, certificates, and instruments of conveyance with the applicable governmental authorities; provided that Assignor shall take such steps and actions, and provide such cooperation and assistance, to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to


effect, evidence, or perfect the Assignment hereunder. In the event Assignee is unable for any reason to perform the actions set forth in this Section, Assignor hereby designates and appoints Assignee and its duly authorized officers and agents as Assignor's agent and attorney-in-fact, to act for and on Assignor's behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of this Section, with the same legal force and effect as if executed by Assignor.

3. This Assignment shall inure to the benefit of the Assignee and its successors and assigns.
4. This Assignment may be executed by each of the parties hereto in separate counterparts, each of which shall be deemed to be an original and both of which taken together shall constitute one and the same Assignment. A signed copy of this Assignment delivered by facsimile, email, or other means of electronic transmission is deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
