RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is made effective as of January 14, 2021, by and from The Scotts Company LLC, an Ohio limited liability company ("Scotts"), to Bonnie Plants, Inc., an Alabama corporation ("Bonnie").

WHEREAS, Scotts and Bonnie are parties to that certain Security Agreement dated as of March 1, 2016 (as the same may be amended, modified, restated or supplemented from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Bonnie granted a continuing security interest in and continuing lien upon certain trademarks and trademark applications to Scotts, as set forth on Schedule 1 attached hereto (the "Trademark Collateral");

WHEREAS, a corresponding Notice of Grant of Security Interest in Trademarks was recorded on March 14, 2016, with the United States Patent and Trademark Office under Reel 005750 and Frames 0915-0921 with respect to the Trademark Collateral; and

WHEREAS, Scotts and Bonnie have reached an agreement such that Scotts has agreed to release the aforementioned security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Scotts hereby agrees as follows:

1. Scotts hereby releases the security interest granted to it pursuant to the Security Agreement in the Trademark Collateral and reassigns to Bonnie any and all right, title and interest Scotts may have had in such Trademark Collateral under the Security Agreement.
2. Scotts authorizes and requests that the applicable officials of the United States Patent and Trademark Office record this Release.
3. This Release may be executed in any number of counterparts (including by telecopy or electronic portable document format (*i.e.*, "pdf")), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
4. This Release shall be governed by, and construed in accordance with, the laws of the State of Delaware.



