**ASSIGNMENT AND ASSUMPTION OF  
SECURITY INTEREST IN TRADEMARKS**

This ASSIGNMENT AND ASSUMPTION OF SECURITY INTEREST IN TRADEMARKS (this "Assignment and Assumption") effective as of January 14, 2021 ("Effective Date") is made by JPMORGAN CHASE BANK, N.A., an Ohio Association having an address of CIB DMO WLO Mail Code NY1-C413, 4 CMC, Brooklyn, New York 11245, as resigning Administrative Agent and resigning Collateral Agent, as assignor ("Assignor") and WILMINGTON SAVINGS FUND SOCIETY, FSB, having an address of 500 Delaware Avenue, Wilmington, Delaware 19801, as successor Administrative Agent and successor Collateral Agent, as assignee ("Assignee").

**WHEREAS**, GARRETT TRANSPORTATION I INC. (the "Grantors") and Assignor entered into that certain Trademark Security Agreement dated September 27, 2018 ("Trademark Agreement") pursuant to that certain Credit Agreement, dated as of September 27, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), with the other grantors party thereto, the Lenders and Issuing Banks from time to time party thereto, and Assignor as the Administrative Agent and that certain U.S. Collateral Agreement, dated as of September 27, 2018, by and among the Grantor, Assignor as the Administrative Agent and other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time) pursuant to which Assignor received from Grantor a security interest in certain intellectual property, including, but not limited to, the trademarks set forth on Exhibit A, ("Trademark Collateral") which Trademark Agreement was recorded at the United States Patent and Trademark Office ("USPTO") at Reel 6446 Frame 0846.

**WHEREAS**, pursuant to that certain Successor Agent Agreement dated as of the date hereof by and among Assignor as resigning agent and Assignee as succeeding agent, among other parties ("Successor Agreement"), Assignor has assigned and transferred to Assignee all of its rights, powers, discretions, privileges and duties under the Loan Documents (including, without limitation, its Liens and security interests in the Collateral).

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the parties hereto agree as follows:


1. Terms not otherwise defined herein shall have the meanings assigned to them under the Credit Agreement.
2. Assignor hereby pursuant to the terms of the Successor Agreement assigns and transfers to Assignee all of its rights, title and interest in, to and under the Trademark Agreement and the Trademark Collateral thereunder.
3. Following the execution of this Assignment and Assumption, it will be delivered to Assignee for recordation at the USPTO. The parties hereby authorize and request the Commissioner for Patents and Trademarks to record this Assignment and Assumption in the USPTO with respect to the Trademark Collateral.

4. This Assignment and Assumption has been entered into pursuant to and in conjunction with the Successor Agreement, which is hereby incorporated by reference herein. The provisions of the Successor Agreement shall supersede and control over any conflicting or inconsistent provision herein.
5. This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.
6. This Assignment and Assumption may be executed in multiple counterparts (including delivery by PDF), each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
