## **TRADEMARK ASSIGNMENT AGREEMENT**

This TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is entered into by and between Veriforce, LLC, a New Mexico limited liability company with offices at Suite 100, 300 Holiday Square, Covington, Louisiana ("ASSIGNOR"), and Safeland, Inc, a Texas nonprofit corporation with an address at 330 Rayford Rd, #750, Spring, Texas 77386 ("ASSIGNEE"), and this Agreement is made effective as of this 5<sup>th</sup> day of JANUARY, 2020 (the "Effective Date").

**WHEREAS**, ASSIGNOR is the owner of the right, title and interest of U.S. trademark application for SAFELAND, U.S. Application No. 88881351 (the "Trademark Application") and the owner of the rights and goodwill to the mark, SAFELAND.

**WHEREAS**, ASSIGNOR desires to convey, transfer, assign, and deliver to ASSIGNEE all its rights, title, and interest in and to the Trademark Application and all associated goodwill.

**NOW THEREFORE**, in consideration of ASSIGNEE paying the sum of One Dollar (\$1.00) to ASSIGNOR and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title and interest of whatever kind in and to the Trademark Application.

ASSIGNOR hereby sells, assigns, transfers and conveys to ASSIGNEE 100% undivided interest to the entire right, title, interest in and to the Trademark Application in the United States and in all jurisdictions outside the United States, together with any goodwill associated with, connected with and/or symbolized by the Trademark Application. By this Agreement, ASSIGNEE is granted the irrevocable right to own, maintain and prosecute the Trademark Application, the right to apply for other trademark Applications within or outside the United States based in whole or in part upon the Trademark Application, and any priority rights that may arise from the Trademark Application or any future trademark Applications based in whole or in part upon the Trademark Application, the same to be held and enjoyed by ASSIGNEE as fully and entirely as said interest could have been held and enjoyed by ASSIGNOR had this sale, assignment, transfer and conveyance not been made.

ASSIGNOR authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record this Assignment and transfer of the ownership of the Trademark Application to ASSIGNEE'S right, title and interest therein. ASSIGNOR agrees to further execute any documents reasonably necessary to perfect and implement this assignment or to confirm ASSIGNEE'S ownership of the Trademark Application.
