TRADEMARK ASSIGNMENT

Agrees that, upon the Assignee's reasonable request it will furnish all necessary documentation reasonably available to the Assignor relating to or supporting chain of title, sign all appropriate papers, take all rightful oaths, and do all rightful acts which may be reasonably necessary for vesting title to, and effecting the transfer and recording of, the Assigned Marks in the Assignee, its successors, assigns and legal representatives or nominees.

This assignment is given with, and only with, the representations and warranties set forth in the Asset Purchase Agreement.


