Pursuant to Title 8, Section 253 of the Delaware General Corporation Law, Sierra Wireless America, Inc., a Delaware corporation (the “Corporation”), does hereby certify to the following:

1. The Corporation is a business corporation organized and existing under the laws of the State of Delaware.

2. The Corporation is the owner of all of the outstanding shares of stock of GenX Mobile Incorporated, Sierra Wireless America Investments, Inc. and Sierra Wireless Services America Holdings Inc., each of which is also a business corporation organized and existing under the laws of the State of Delaware.
