TRADEMARK ASSIGNMENT

WHEREAS, Safari owns all right, title, and interest in and to the trademark listed below (the "Mark") which is registered in the United States Patent and Trademark Office in connection with the services listed below:

WHEREAS, Steam desires to acquire and Safari desires to transfer to Steam all of its right, title, and interest in and to the Mark, including that part of the goodwill of the business connected with the use of and symbolized by the Mark;

NOW THEREFORE, for good and valuable consideration as set forth in the Asset Purchase Agreement of which this Trademark Assignment is a part, and the receipt and sufficiency of which are hereby acknowledged, Safari does hereby agree as follows:

1. Trademark Assignment: Assignor does hereby assign and transfer to Steam all of Assignor's right, title, and interest in and to the Mark, including all common law rights, together with that portion of Assignor's business to which the Mark pertains, and that portion of the goodwill of Assignor's business symbolized by the Mark, and any registration and renewals for the Mark or any variations of the Mark that may be secured under any laws or treaties now or hereafter in force in the United States and in all other countries of the world. Assignor further transfers and assigns the right (but not the obligation) to assert such registered trademark and other assigned rights to collect for all past, present, and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur.

2. Cooperation in Vesting and Enforcing Assignee's Acquired Rights. Safari agrees to execute, verify, acknowledge, and return at the request of Steam, all documents necessary or

desirable to perfect and vest in Assignee all right, title, and interest in and to the Mark, and all documents necessary or desirable to protect and enforce such right, title, and interest.

3. Successors and Assigns. This Agreement shall be binding upon the successors and assigns of Assignor and shall inure to the benefit of Assignee's successors and assigns.

4. Counterparts. The Parties agree that this Agreement may be signed in electronically transmitted counterparts, and that such signed counterparts when read together shall be accorded the same legal significance as a single document bearing the original signatures of both parties.
