TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of January 19, 2021, and made by **TREE LINE DIRECT LENDING, LP** (the "Grantee"), to **LILLEBABY, LLC** ("Borrower") and **LILLEBABY HOLDING COMPANY, LLC** ("Holdings", and together with Borrower, the "Grantors", and each a "Grantor").
