**TRADEMARK ASSIGNMENT AGREEMENT**

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment Agreement"), effective as of September 23, 2020 (the "Effective Date") is made and entered into by and among Visplay International AG, a Switzerland corporation, located at Klunefeldstrasse 22, 4127 Birsfelden, Switzerland ("ASSIGNOR"), and Ansorg GmbH, a Germany corporation, located at Pilgerstrasse 11, 45473 Mulheim an der Ruhr, Germany ("ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of all rights, title and interests, *inter alia*, in and to the trademark ANSORG, and owns the United States trademark registration for the trademark ANSORG as identified in Schedule A (the "Trademark");

WHEREAS, ASSIGNOR desires to transfer all rights, title and interests in and to the Trademark to ASSIGNEE;

WHEREAS, ASSIGNEE desires to acquire all of ASSIGNOR's rights, title and interests in and to the Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which is hereby acknowledged, ASSIGNOR does hereby irrevocably sell, assign, grant and transfer to ASSIGNEE, its entire rights, title and interests in and to the Trademark, including all common law rights, along with the goodwill of the business symbolized by the Trademark, the same to be held and enjoyed by ASSIGNEE for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment had not been made, as assignee of its entire right, title and interest therein, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment Agreement.

This Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademarks, to record this Assignment Agreement, and to issue or transfer the said trademark record(s) to the ASSIGNEE as owner of all right, title and interest therein, or otherwise as the ASSIGNEE may direct, in accordance with the terms of this Assignment Agreement.
